RE: Claims Denials for Invalid Diagnosis for Age of this Member

The HSCSN Claims Department has identified a significant number of claim denials due to an incorrect diagnosis or procedure code: "Invalid diagnosis for age of this member". When submitting your claim(s), you must verify that the diagnostic code used is age-appropriate and aligns with the services rendered (i.e., CPT/HCPCS codes). For example, you should not use a newborn diagnostic code for a sixteen-year-old.

If your authorization letter has a diagnosis or procedure code(s) that is not consistent with the services to be rendered, please contact the HSCSN UM department at 202-721-7162 and leave a detailed message requesting an update to the authorization. Please do so prior to submitting a claim. The HSCSN UM Department will work with you to ensure authorizations are up to date.
